Salary Conversion of Tri Forces Members in accordance with Public Administration Circular No.14/ 2019 : General Instructions

01. The same Information Technology System provided can be used for Tri Force Officers in accordance with Public Administration Circular No.14/2019. Access to Army Pension Conversion could be done using the new Revision Forces menu Icon.

02. The following types of pensions should only be used for the conversion of Tri Forces pensions: (The instructions are given in the instruction letter 01)

03 - Armed Forces Pensions

40 - Armed Forces widows' Pensions

41 - Armed Forces Orphans' Pensions

43 - Armed Forces Guardian Pensions

44 - Armed Forces Widowers' Pensions

45 - Armed Forces Widowers' & Orphans' Pensions

60 - Re-Married Army Widows'

63 - Re-Married Army Widowers'

69 - Service Pension bellow 10/12 service periods completed 55 years –Tri Forces

03. The military service the relevant officer belongs to, should be selected as 'service' in the tri forces pension conversion system.

- Sri Lanka Army
- Sri Lanka Navy
- Sri Lanka Air Force

04. The rank of the officer should insert in the designation.

05. The accurate salary code in accordance with Public Administration Circular No.06/2006 should enter to the system.

06. The pension percentages of forces pensions are calculated purely based on the service period and other operational activities does not link with the salary, therefore the exact percentage in the pension award should be awarded after the revision Hence the facilities are provided in the system to alter the pension percentages to tally with the percentages of the award.

07. Salary conversion tables and grades to be selected in respect of each officer category are as follows.

07. Only the accurate service period of the officer should be entered to the system.

08. **No change will be made in the pensionable allowances entitled by the Tri Force officers.** Therefore enter the annual amounts according to the pension award.

09. Conversion tables in respect of the Pension conversion for the Tri Force officers are mentioned in the Public Administration Circular No.14/2019.

10. This pension revision shall be made in association with the pension file available in the pensioner's name maintained in the Divisional Secretariat. In case of misplaced or information unavailable files, temporary file should be prepared and should be submitted for the approval of Department of Pensions.

11. Payments for the remarried widows'

50% of the revised pension is entitled for the remarried widows'/widowers' pension recipients. Actions should be taken to amend the pension types since 2019 July for the convenience of identification of these pensioners.

12. This pension conversion is not regarded for the pensioners (and widows) who are paid the monthly salary until 55 years of age.
