Entitlement of Ranaviru Surakum Allowance for Disabled Officers of Tri Forces and Widows/Widowers

Instructions had been issued by the Pension Circular No 01/2017 regarding the entitlement of Ranaviru Surakum Allowance to the disabled members of the tri forces and widows of the members of the tri forces, who have disabled/deceased as a result of terrorist activities.

- 02. Approval has been granted to provide a fixed monthly allowance to the eligible disabled members of the tri forces from 24.09.2019 according to the Defence Circular No MOD/DEF/GS/SALW/4/SLA(I) dated 24.09.2019 and to the widows/widowers of deceased members of tri forces who are eligible under the section (i), (ii) and (iii) of the Pension Circular no 01/2017 according to the Defence Circular No MOD/01/2021 dated 18.05.2021 from 27.04.2021. The Surekum Allowance payment was discontinued from the above mentioned dates.
- 03. However, the disabled members of tri forces who failed to submit the Surakum Allowance applications before 24.09.2019 and Widows/Widowers of deceased members of tri forces who failed to submit the Surakum Allowance applications before 27.04.2021 to the Department of Pensions due to various administrative lapses are entitled to receive the arrears of the Surakum Allowance. The instructions regarding the payment of the arrears are given below.
- 04. Tri forces must submit applications along with the salary particulars (at the age of 55) of disabled members of tri forces and deceased members of tri forces, who are eligible for the Ranaviru Surekum Allowance to the relevant Divisional Secretariats, which pay their pensions. The Divisional Secretariat should submit an AR request through DS Portal for arrears payment of the Ranaviru Surekum Allowance. The "Forces Surakum Allowance Arrears" should be selected under the Reason field. Revised Pension Award at the age of 55 years and calculation documents should be submitted as attachments.

- 05. Once the Ranaviru Surekum Allowance is paid, a report should be included in the pension file and a copy of it should be provided to the pensioner.
- 06. As the allocation for the payment of Ranaviru Surakum Allowance expires with the year 2021, please be informed to pay all the outstanding payments before 31.12.2021
